

## PRIVACY NOTICE and POLICY UPDATE ON PERSONAL DATA PROCESSING

The non-profit organization **FUNDACIÓN VALLE DEL LILI**, a legal person according to Resolution N° 6337 dated June 21, 1983, of the Ministry of Health identified with TIN 890324177-5 as stated in the Certificate of Existence and Legal Representation issued by the Governorate of Valle del Cauca, with legal address at Cra. 98 #18-49 in Cali, telephone 3319090 and web address [www.valledellili.org](http://www.valledellili.org), as the person responsible for the processing, will carry out the processing of your personal data, according to our new policy published at [www.valledellili.org](http://www.valledellili.org)

**1. PROCESSING AND PURPOSE:** The processing to be carried out by **FUNDACIÓN VALLE DEL LILI** on the personal information will be the following: Collection, storage, use, circulation, utilization, archive, and any form of processing of your personal data for the purposes inherent to the institution, including supporting medical assistance, sending information to your insurance company, managing payment processes, conducting satisfaction surveys, preparing statistical, scientific and/or investigational studies; sending through any channel available (e-mail, SMS, printed), diagnostic test results; business, academic, commercial, and/or promotional information of **FUNDACIÓN VALLE DEL LILI**, its commercial and/or strategic partners, always related to its corporate purpose. Also in accordance with our data protection policy.

**2. HOLDER'S RIGHTS:** As the holder of your personal data, you have the following rights: (i) Free access to personal data provided that have been processed. (ii) To know, update, and rectify your information against partial, inaccurate, incomplete, fractioned, or misleading data or any data whose processing is prohibited or unauthorized. (iii) To request proof of granted authorization. (iv) To submit complaints to the competent authority regarding breaches of the provisions set forth in the current regulations. (v) To withdraw the authorization and/or request the deletion of data, as long as there is no legal or contractual duty that prevents its deletion. (vi) To refrain from answering questions about sensitive data. Answers concerning sensitive data or data on children and adolescents shall be optional.

**3. MECHANISMS FOR KNOWING THE PROCESSING POLICY** If you would like your data to be deleted from our databases, we require an explicit statement within thirty (30) working days from the publication of this notification to [datospersonales@fvl.org.co](mailto:datospersonales@fvl.org.co). Otherwise, it shall be deemed that you give us consent to use it for the purposes described above.
